RULES AND REGULATIONS

1. **USEF:** The Southern Magnolia Classic is a US Equestrian Federation licensed competition. Every class offered herein, which is covered by the rules and specification of the current Federation rule book, will be conducted and judged in accordance therewith. The rules of the Federation take precedence over the rules of any other association. Exhibitors are encouraged to refer to the current Federation Rule Book, which is available at www.usef.org. A Federation Steward approved by the Show Committee shall be present to administer these rules at the show.
2. **AHA:** Horses shown in the Arabian division must have been issued a certificate of registration from the Arabian Horse Registry of America, Inc. (or in the case of foreign entry, have been issued a competition visa by the AHR of America), and/or the Canadian Arabian Horse Registry or, if under one year of age, be eligible for registry and registration applied for (Exception AR236.1 and must be entered under their full registered name).
3. **GVHS: All horses in classes marked GV must be registered as purebred with the Gypsy Vanner Horse Society or other Gypsy Horse registry.** Only those registered with the GVHS will be eligible for GVHS points. The Southern Magnolia Classic will follow the current GVHS Rulebook for classes marked GYPSEY. It can be found at www.vanners.org. Consult this rulebook for class-specific rules.
 - a. Competition entries will include a Proof of Registration or Pending Registration.
 - b. Age of all horses is determined as of January 1 of the year they were born.
 - c. Classes where Gypsy Vanners compete in the same class with other breeds will not be eligible for GVHS year-end show points.
 - d. Registered Purebred Gypsy Vanner horses cannot compete in any driving or riding class until they are three years old.
 - e. Horse/rider combinations cannot cross enter WT and WTC.
 - f. All persons exhibiting as Amateurs must have an Amateur Declaration Form on file with their breed registry in order to compete in Amateur classes and must include a copy of their 2026 Amateur card with their entries.
 - g. Classes may be combined or divided based on the size of the Competition and the discretion of the Competition management.
 - h. Mares and foals may accompany each other in the ring for all in hand classes. Foals must be haltered and under control.
 - i. Competition Management will resolve any questions or dispute that may arise from said eligibility of horses. This decision will be final.
4. **IFSHA:** Owners and their horses are to be members of the IFSHA Association and USEF to participate in the Show and must be current with the USEF Safe Sport Initiative. Non-owners exhibitors (Jr. Exhibitors/Open) may purchase a IFSHA Show Pass and USEF Show Pass to compete. Adult Amateur Exhibitors must be members of USEF and be current with the USEF Safe Sport Initiative. **IFSHA Memberships (Owner & Horse) are to be completed at the IFSHA Office at least 5 days in advance of the start of the show.**
5. **IALHA:** Owners and their horses are to be members of the IALHA Association and USEF to participate in the Show and must be current with USEF Safe Sport Initiative. Non-owner exhibitors (Jr. Exhibitor/Senior) may purchase a IALHA Show Pass and a USEF Show Pass to compete. Amateur Exhibitors must be members of USEF & be current with the USEF Safe Sport Initiative.
6. **OPPORTUNITY CLASSES:** Will be conducted in accordance with USEF rules and specifications. Opportunity classes will be open to all breeds. There will be no USEF membership requirement or drug fees for exhibitors and/or horses entering only Opportunity Classes. Exhibitors and/or horses **may cross-enter** between opportunity and recognized classes if eligible.
7. **HORSE SHOW EXECUTIVE COMMITTEE:** The HS Exec Committee reserves the right to itself, to interpret all questions and conditions regarding, or arising out of, or incident to, the show, without claims for damages or recourse of any kind. Any question not covered in these rules and regulations shall be decided by the Horse Show Executive Committee, their decision to be final. The Horse Show Executive Committee is to consist of Horse Show Manager (Lynn Daniel) and Horse Show Secretary (Marie Taylor).
8. **MANAGEMENT** reserves the right to refuse, accept conditionally, or cancel any entries, and to cancel award prizes, without claims for damages; to change any course, to cancel or combine any unfilled classes; and to change judges or other officials. Class Schedules: The Tentative Class Schedule is included in this booklet.
9. **MANAGEMENT** reserves the right to adjust the class schedule and class order. If entries warrant, performance may begin earlier or later than published. Please check with the horse show office for each day's final schedule. Management reserves the right to cancel classes due to scheduling and/or weather. Classes may be combined or divided based on the size of the Competition and the discretion of the Competition management.
10. **SHOW OFFICIALS:** In the event of illness or failure of a judge or any other official to attend this show or to perform his duties, the show committee reserves the right to substitute an official for the one who was officially designated in the prize list, according to USEF rules.
11. **HORSE SHOW OFFICE:** will be open Thursday from 9:00 AM to 7:00 PM. The office will open one hour prior to the first class each day and will remain open for 30 minutes after the last class each day. The Horse Show Office telephone number is (804) 314-5216 (Marie Taylor, Show Secretary).
12. **RESPONSIBILITY:** Submission of entry to this show constitutes an agreement to the following: Exhibitor agrees to indemnify and hold harmless MAHA, Inc., IALHA, IFSHA, GVHS, GHSA, USEF, Show Management, their officers, respective directors, agents, employees or representatives against any claims, demands, costs and expenses, including reasonable attorney fees for the defense thereof, arising from the conduct or management of Exhibitor's business or its use of the premises or from any breach on the part of Exhibitors of any conditions of this Agreement, or contractors, agents, employees, guests, or invites in or about the premises. In case of any action or proceeding brought against MAHA, Inc., IALHA, IFSHA, GVHS, GHSA, USEF, Show Management or their officers, respective directors, agents, employees or representatives by reason of any such claim, Exhibitor, upon notice covenants to defend such action or proceedings by counsel, acceptable to MAHA, Inc., IALHA, IFSHA, GVHS, GHSA, USEF, or Show Management. Exhibitor is responsible for his/her own property.
13. **DISCIPLINE:** Exhibitors are cautioned that any act of discourtesy or disobedience to the officials on the part of the owner, lessee, trainer, groom, rider, driver or their families will disqualify the horse from adjudication. The management reserves the right to remove an owner, lessee, trainer, groom, horse, rider, driver from the show without being liable for compensation or damages. Show management will be charged with the responsibility of enforcing all USEF and AHA rules. Questions not covered decided by management and final.
14. **INDEMNITY AND RESPONSIBILITY:** All entries are accepted with the understanding that neither the Tryon Int'l Equestrian Center, Magnolia Arabian Horse Assoc., Inc., its officers, the Show, The Show Committee, Show Official nor any of its sponsors will be held responsible for any loss, damage, or injury to any horse exhibited or any article of any kind. All horses shall be under the control and direction of the show committee but solely at the risk of the exhibitor, who will be responsible for any loss, damage, or injury to any

person, animal or property occasioned by him, and the exhibitor shall indemnify the above mentioned parties against any and all loss, damages and liability thus occasioned, including but not limited to any and all legal costs, including attorney fees, which may be incurred as a result thereof. THE SUBMITTING OF AN ENTRY FORM TO THE SHOW SHALL CONSTITUTE AN ACCEPTANCE BY EACH PERSON SIGNING SAME OF THE PROVISIONS HEREIN SET FORTH.

15. **PROTEST:** Must be filed in accordance with the USEF rules and be accompanied by a deposit of \$200 for members or parent of junior exhibitor and \$300 for non-members which will be forfeited if the protest is not sustained (See GR603 (d)).
16. **PARKING:** No trailers or vehicles will be allowed to be parked in barn area. No electrical cords may be run from any barn.
17. **ARENA:** Indoor arenas open Thursday a.m. **NO LUNGEING HORSES IN THE INDOOR ARENA.** Sizes 125' x 250' – Footing sand/sawdust mix, main and warm-up rings. No person will be permitted to enter the arena, upon start of show, except participants in class, judges and their assistants, show photographer and assistant, show officials and staff. Attendants will not be permitted in the arena unless summoned by the judge.
18. **PROFESSIONAL SERVICES:** by the Show Veterinarian or Farrier outside the ring on a Private Fee Basis. The name and phone number of vet posted at show office and barn office.
19. **CALLS FOR CLASSES:** Classes called promptly. Two-minute clock begins when the gate opens, the in-gate MUST be closed at the end of 2 minutes after the first horse enters the ring (GR310.1) Entered the same horses in back-to-back classes, a tack hold should be arranged with the paddock. Maximum 3 minutes allowed. Always check-in with paddock master. Problems with mechanical device, the PA system and paddock calls must be considered a courtesy. Responsibility of exhibitor to be sure his horse is at the gate at the prescribed time. Every effort will be made to maintain a working PA system to carry calls, no protest will be upheld, nor will any section be changed on the basis of a PA malfunction. Management has the right to cancel any class not filled or change classes in case of bad weather.
20. **AGE OF INDIVIDUALS:** show purposes, individual's age on December 1 shall be maintained throughout the entire year. Born December 1 assume the greater age of that date.
21. **INDEBTEDNESS TO SHOW:** Failure to settle Indebtedness will be barred from taking part USEF Recognized Shows until settlement is made. USEF (GR1508). Remedies available to the show under USEF rules for non-collect ability of checks show management will assess a fee of \$125.00 if a check is returned unpaid. Unless, secretary confirms arrangements, each exhibitor who leaves at close of show without settling any fees, will be assessed a \$25.00 service fee for sending bill. All fees will be settled at time of checkout.
22. **REFUSAL OF ENTRIES:** The Show Committee and the Management reserve the right to refuse, accept conditionally or cancel any entry, disqualify exhibitors, prohibit exhibition of entries and remove from the grounds any individual, stable or both without claim for damages. The submitting of an entry form to the show shall constitute an acceptance by each person signing same of the provisions herein set forth. See USEF GR1509.1
23. **ENTRIES:** All AHA/IALHA/IFSHA owners, riders, drivers and handlers MUST have Current USEF, AHA and WDAA memberships (if applicable). The entry blank provides space for signatures, address of the trainer, owner or agent, rider, driver, handler of each entry. Under age 18 may not sign as trainer, USEF GR 906-909. **ALL MONEY MUST ACCOMPANY THE ENTRY FORM AND BE PAID BEFORE NUMBERS CAN BE ISSUED (NO OPEN CHECKS. ALL ENTRIES SENT WITH AN OPEN CHECK WILL BE CHARGED A POST ENTRY FEE PER HORSE!!).** Absolutely no numbers will be given out without all card and papers when you check in with the show office. For any entries missing current memberships a \$25 incomplete entry fee will be added to your account.
24. An **OPEN/SIGNED CHECK** will be required to add any classes or bedding, etc at the show. Any additional charges must be paid before leaving the show grounds. Any unpaid charges will be invoiced within 30 days and will be assessed a \$25.00 service fee. Failure to pay within 30 days will be considered an unsportsmanlike act and may result in actions taken against such conduct in accordance with USEF rules. There will be a \$100 charge for any checks returned or declined credit cards.
25. **STALLS:** 10 x 10 wooden box stalls with metal bar front one sliding door. Exhibitors will be required to rent one stall per horse. Horses must be assigned a separate stall (except for broodmares with suckling foals). Horses must be placed in stalls assigned and no changes will be permitted except with the express consent of the Barn Manager. **Any exhibitor using an unassigned stall will be charged \$100 per stall.** This is strictly enforced.
26. **BEDDING:** Please preorder bedding, if you will be arriving after 5pm on any afternoon you will not receive bedding unless preorder was placed with entries (then bedding will be waiting for you in your stalls). There will not be anyone on grounds to distribute bedding after 5pm. **NO ARRIVALS BEFORE 5pm WEDNESDAY!**
27. **POST ENTRIES:** Mailed Pre-Entries close on August 10th. Mailed entries postmarked after this date will automatically be considered Post Entries and assessed the post entry fee as shown in the fee schedule. Extra classes for pre-entered horses will not be post entries, however, no horse may be substituted for horses already entered. Entry blanks must be completed and returned before closing date. **Post entry fee will be charged if postmarked or emailed after the closing date. DO NOT MAIL AFTER AUGUST 14TH – please enter online at RingRadar or bring entries to the show.** Entries made ONLINE AFTER AUGUST 17th will be considered Post Entries and assessed the post entry fee shown in the fee schedule.
28. **REFUND POLICY:** Withdrawal of entries must be made in writing and accompanied by a vet certificate. Those received before closing date will be refunded all fees except office fee. After closing date, until start of show, all fees will be refunded except office, one class and stall fee. Post entry fees will be retained. **Absolutely no refunds on stall fees after closing date.** Refund of AHA/USEF fees exhibitor/owner must inform office at the time horse is taken out of last class that it will not be shown. **No Refunds on Dressage classes for any reason!**
29. **ENTRY AND SCRATCH POLICY:** Entries being added MUST be made by the end of the session prior to the session being entered, not during breaks, office closed. Class fees will be refunded if you scratch your class before the class prior to yours is lined up. Qualifying Class MUST be scratched in office or **by signature with Paddock Master.** Last class fee for a horse will be kept.
30. **PENALTY POLICY:** In the event the Southern Magnolia Classic Horse Show, management or officials are fined by any organization owing to an exhibitor's infraction of the rules or requirements, said fine will be charged to the exhibitor plus a 10% penalty.
31. **MOTORIZED VEHICLES:** Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above-described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian, or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be

cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

32. **CLASS SPECIFICATIONS:** The rated Sections of this Competition are official USEF point competitions for the USEF National and USEF Service Company Zone Horse of the Year Awards Programs. Exhibitors encouraged to read the USEF Rule book, particularly CHAPTER AR, for the complete Arabian horse rules, class descriptions and judging specifications.
33. **SHARPS CONTAINERS:** Competition management shall place a minimum of one sharps container per each competition, whether stabling is provided. Additionally, at least one sharps container per fifty occupied stalls for the disposal of needles and other disposable sharp instruments in convenient locations in barns housing competition horses. It is competition management's responsibility to replace such containers when full and dispose of them properly. Competition management may fine any individuals including trainers, owners, exhibitors, or their agents up to \$100 for improper disposal of needles or other sharp disposable instruments. **Competition management will place a notice of this requirement either in its prize list or on a specific handout given to trainers on check in at the competition.** If local law has different requirements, local law will prevail. GR1210.4.
34. **PROTECTIVE HEADGEAR:** In accordance with USEF rules, all juniors riding in Hunt Seat Equitation Over Fences and Not to Jump, Hunter Over Fences and Jumper classes must wear protective headgear passing applicable ASTM standards (must be stamped inside helmet) while riding in designated schooling and exercise areas, the show ring and while jumping anywhere on the show grounds.
35. **DRESSAGE EXHIBITORS** please refer to USEF DR 120 for protective headgear rules.
36. **FOOD SERVICE:** Available on the grounds.
37. **NEW IN 2024: PER GR1215.4:** For 6 consecutive hours overnight, stabling must have minimal lighting and noise to allow stabled horses adequate rest. *** STABLE LIGHTING WILL BE REDUCED FROM 11PM - 5AM ***

Class Information

EVERY CLASS OFFERED HEREIN WHICH IS COVERED BY THE RULES AND SPECIFICATIONS OF THE CURRENT FEDERATION RULE BOOK WILL BE CONDUCTED AND JUDGED IN ACCORDANCE THEREWITH.

Exhibitors are encouraged to read the FEDERATION rule book, and particularly Chapter AR, for the complete Arabian horse rules, class descriptions and judging specifications.

JUNIOR EXHIBITOR: Junior exhibitors shall not have reached their 18th birthday. For horse show purposes, the age of the junior exhibitor on December 1 of the show year shall be maintained throughout the entire year.

AMATEUR: Every rider having reached his/her 18 th birthday prior to 12/1 must have in their possession an amateur card issued yearly by USEF or make application for such card at least one hour prior to showing in an Amateur class. GV Amateurs must have an Amateur Declaration Form on file with their breed registry in order to compete in Amateur classes and must include a copy of their 2025 Amateur card with their entries.

OWNERS CLASSES – Combined ownership is not permitted in Owners or Amateur Owners classes unless all owners are members of the same family. For competition purposes the term "family" includes husband, wife, parent, stepparent, child, brother, stepchild, sister, half-brother, half-sister, aunt, uncle, niece, nephew, grandmother, grandfather, and in-laws of the same relations as stated above. Leased horses are not eligible. Horses entered in amateur owner and junior owner classes must be registered in the name of the competitor or a member of the competitor's family, as defined by USEF GR122. The sale of a horse does not eliminate this requirement. (Contracts of Sale or Bill of Sale will not be accepted). USEF AR101.2

FOR ALL EQUITATION RULES: Refer to USEF RULE 25, 219-225

- a. **AHA Hunter Seat Over Obstacles Medal class.**
 - 1) To be shown over a course of not fewer than six obstacles with fence heights of 2'6" to 3' of which must include an oxer and two changes of direction (changes of lead).
 - 2) Two or more tests of the top four contestants are required from USEF Equitation Division EQ 113 - Tests 1 -7, 9-15, 17-19 (EC equivalent).
- b. **AHA Saddle Seat Medal class.**
 - 1) In addition to the rail work, all contestants are required to perform two or more individual tests from USEF Tests (EQ 120) 1-15 (EC equivalent). Markers shall not be used. USEF Test 16 may only be called for at the National Shows.
- c. **AHA Reining Seat Medal class.**
 - 1) All contestants are required to perform a Reining pattern as outlined in USEF Reining Division (EC equivalent).
 - 2) Order of go will be done by draw.
 - 3) Bits must be dropped and inspected by the Judge or designated official, and all riders must dismount for this inspection. If called for in the ring, assistance, if necessary, may be had from one of the ring officials.
 - 4) Reins shall not be removed from the horse's neck while inspecting bits.
 - 5) In the event the total score is tied, the tie will first be broken by the exhibitor with the highest equitation score. Should a tie still exist, the tie shall be broken by reining rules in RN 103.2.
 - 6) It is mandatory that judges use the prescribed AHA Score Sheet for Reining Seat Equitation and that the score sheet or a copy be posted immediately after each class.
- d. **AHA Hunter Seat Not to Jump Medal class.**
 - 1) In addition to the rail work, all contestants are required to perform two or more tests from USEF Equitation Division, EQ 113. Tests From Which Judges Must Choose.
- e. **AHA Western Horsemanship Medal class.**
 - 1) In addition to the rail work, all contestants are required to perform a minimum of four tests from USEF Arabian, Half-Arabian/Anglo-Arabian Division, Subchapter Western Horsemanship, AR-26.)

UPHA CHALLENGE CUP: refer to UPHA rules and regulations, AHA Article 1121.

WALK TROT/JOG 10&U: (See USEF AR305) Open to riders 10 years old & under as of December 1 of current competition year. A rider must have never been judged in a class at licensed competition that required a canter or lope. No cross entries into any other classes except halter or showmanship. NO STALLIONS ALLOWED. One header per horse during line-up; a plain, unmarked smock is required.

WALK TROT/JOG 11&O: (See USEF AR317) Open to Amateur or Junior Exhibitors 11 years old and older as of December 1 of the current competition year. An Amateur card is not required for ATR/AATR Walk-Trot/Walk-Jog 11 and over classes. No cross entries into any other classes except halter or showmanship. Headers are allowed.

LEADLINE: Rider 2 to 6 years of age and never shown alone, no cross-entry is allowed into any other class in the show. If the horse entered is not entered in any other class in the show, stall fee, and office fee must be paid. STALLIONS NOT ALLOWED.

Leaders must be at least 14 years of age. One rider per horse. AHA 237

ANGLO-ARABIANS: All Half Arabian classes are open to Anglo Arabians. HA/AA colts/stallions may compete in weanling and yearling halter classes for Geldings; however, HA/AA/colts/stallions two years old and older are excluded from all halter classes.

PUREBRED HALTER: Champions and Reserve Champions must be at least two years old. Yearling geldings are the only yearlings that may compete for Champion Halter.

ALL HALTER CLASSES MUST BE ENTERED BY 5PM TUESDAY - NO EXCEPTIONS

YOUTH HALTER AND SHOWMANSHIP: STALLIONS CANNOT SHOW.

DRESSAGE: Dressage competition will be conducted according to USEF Rule XIX. 2023 USEF Tests and USDF 2023 Introductory Tests will be used. Post entries accepted if ride times are available. Official ride times to be posted at the show.

NC "WARNING" – Under North Carolina law, an equine activity sponsor or equine professional is not liable for an injury to or the death of a participant in equine activities resulting exclusively from the inherent risks of equine activities, pursuant to Chapter 99E of the North Carolina General Statutes.

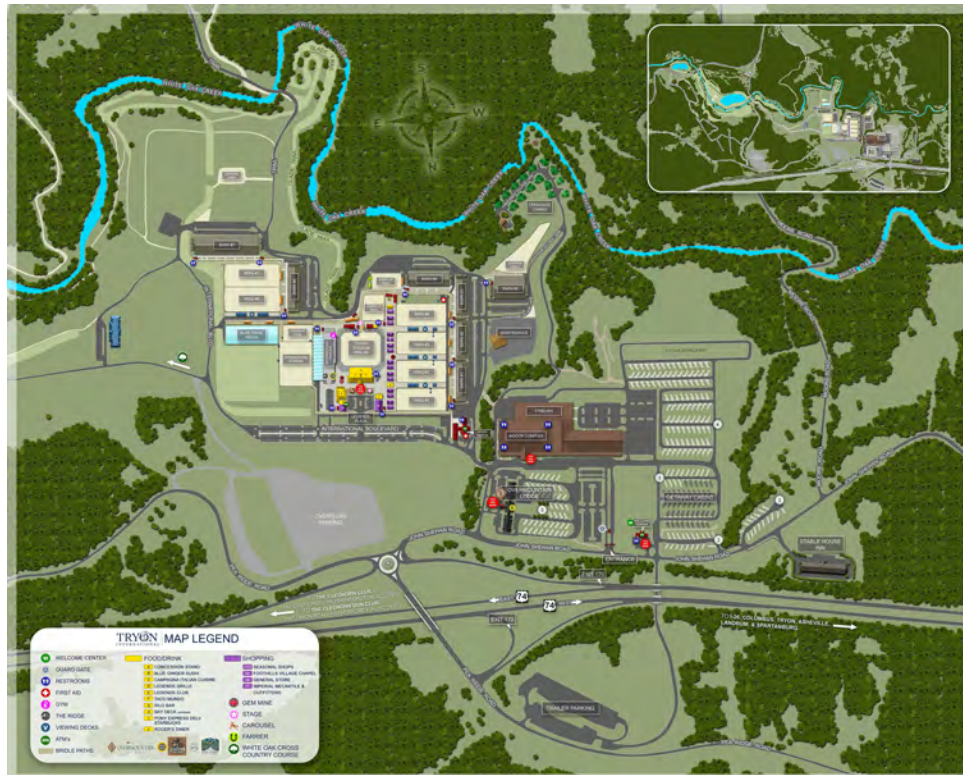

DIRECTIONS TO TRYON INTERNATIONAL EQUESTRIAN CENTER (25 International Blvd., Mill Spring, NC 28756):

From Asheville: Get on I-26 E / US 74 E, then take exit 67, US 74 E to Columbus/Rutherfordton. Drive 8 miles, then take exit 170. Follow the signs.

From Charlotte: Get on I-85 S, then take exit 10B to get on US 74 W. Drive 46 miles, then take exit 170. Follow the signs.

From South Carolina: Get on I-26 W, then take exit 67 to US 74 E Columbus/Tryon. Go straight through the roundabout off the exit, then veer right towards Forest City/Shelby to get on US 74 E. Drive 8 miles, then take exit 170. Follow the signs.

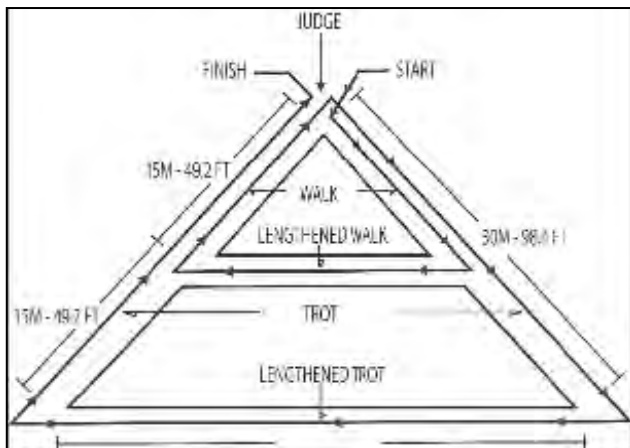

A. RULES AND REGULATIONS: I hereby agree that I have read, understand, and agree to be bound by all applicable Federation Bylaws, rules, and policies including the USEF Safe Sport Policy and Minor Athlete Abuse Prevention Policies (MAAPP) as published at www.usef.org, as amended from time to time.

B. AHA ASSUMPTION OF RISK, RELEASE AND INDEMNIFICATION This document waives very important legal rights. Read it carefully before signing.

In consideration for AHA permitting me to participate in this Competition, and by signing the entry blank, I agree as follows:

I AGREE that I choose to participate voluntarily in this Competition, as a rider, driver, handler, lessee, owner, agent, coach, trainer, junior exhibitor, or as a parent or guardian of a junior exhibitor. **I AM FULLY AWARE AND ACKNOWLEDGE THAT HORSE SPORTS AND PARTICIPATION IN THIS COMPETITION INVOLVE SERIOUS RISK OF HARM INCLUDING, BUT NOT LIMITED TO, RISKS OF ACCIDENT, SERIOUS BODILY INJURY, INCLUDING DEATH, BROKEN BONES, HEAD INJURIES, TRAUMA, PAIN, AND SUFFERING, AND PROPERTY DAMAGE. I ASSUME ALL RISKS OF HARM TO ME, MY HORSE OR MY PROPERTY.**

I AGREE as a Horse Show Participant (or Parent/Guardian of Participant if a minor) to waive all claims which may otherwise arise from, including but not limited to infectious bacteria, viruses, fungi/mold, parasites or other agents which may be present at the Horse Show (and most other outdoor locations) and can cause infection in humans, as well as in animals.

Membership Requirements for WDAA Recognized Shows

WDAA Membership and Horse Numbers: Please include your membership number and your horse's ID number on entry forms when you enter any recognized show.

Online (a.k.a. Virtual) Shows: WDAA membership is required for exhibitor and owner if the horse is earning points in a WDAA award program.

Live Shows (a.k.a. Schooling): WDAA membership is required for exhibitor and owner if the horse is earning points in a WDAA award program.

USEF Lite Shows: WDAA membership is not required for exhibitor, owner, or trainer, but membership is required for exhibitor and owner if the horse is enrolled in a WDAA award program to earn points. USEF membership is required for those eligible for HOTY points; trainer/coach must be USEF competing member.

USEF Local Shows: WDAA membership is required for exhibitor, owner, trainer, coach, lessee, and agent or pay a non-member show pass fee equal to fee for membership. USEF membership is required only for amateurs and those eligible for HOTY points; trainer/coach must be a USEF competing member.

USEF Regular Shows: WDAA membership is required for exhibitor, owner, trainer, coach, lessee, and agent or pay a non-member show pass fee equal to the fee for membership. USEF membership is required or pay \$45 show pass fee; trainer/coach must be a USEF competing member.

WDAA Award Programs

WDAA offers two programs to reward your horse(s). Exhibitor and owner must be WDAA active members, and the horse must have been assigned a WDAA ID number to be eligible to participate in the award programs.

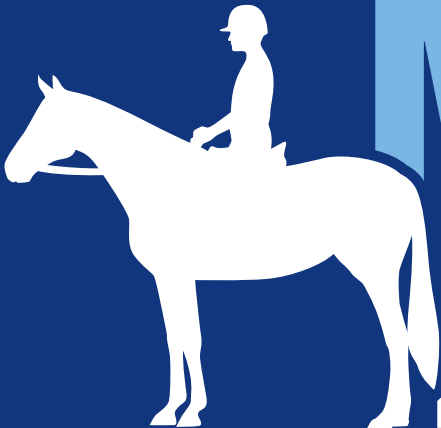
